- A treasury Challan amounting to Rs. 1000/- in case of new license and Rs. 1200/- in case of renewal of license is to be attached and the amount shall be credited to the following head account:-
  - i) 0210-Medical & Public Health
  - ii) 03-Medical Education Training & Research
  - iii) 101-Ayurvedic Receipt
- Two copies of map of premises (Blue print) showing area of each room and indicating the purpose for which these are to be used.
- Two copies of the equipment/machinery installed for manufacturing purposes. The list of laboratory equipments shall also be submitted in two copies.
- An attested copies of the latest two photograph and qualifications/experiences/registrations etc. of the technical staff appointed for manufacturing and testing purpose as prescribed in Schedule 'T' of Drugs and Cosmetics Rules, 1945.
- The affidavit of technical staff with regard to the certification that they will work in firm as full time employee and they have never been convicted under Drugs and Cosmetic Rules or any law of the land.
- A copy of memorandum in case of limited or private limited or copy of the partnership deed (if applicable) on Rs. 10/- stamp paper duly attested First Class Magistrate or Public Notary.
- Proof of ownership of the building or rent deed (if on rent).
- An affidavit on Rs. 3/- non judicial paper duly attested by Magistrate Class-I of each partner/owner that they have never been convicted under the Drugs and Cosmetics Act, 1940 and Rules made thereunder.
- An affidavit attested by Magistrate Class-I to the effect that -
  - i) The building in which manufacturing work is carried out is not used for residential purpose.
  - ii) The firms shall fulfil the all norms mentioned in Schedule 'T' of Drugs and Cosmetic Rules, 1945.
  - iii) The raw drugs to be used in formulations or single medicines shall be tested before their use as per Ayurvedic Pharmacopeias and the finished Drugs shall also be tested before launching them in market for sale and distribution as per quality control references of the said formulations. The batch wise record of all testing shall also be maintained.
- The all conditions of license shall be fulfilled.
- Five typed copies of list of item to be manufacture shall be submitted along with proof of concept and testing protocols (Quality Control References) and clinical trial report on at least 20 patients performed in two Govt. institutions and by one leading qualified Doctors in Ayurveda, Siddha and Unani.
